## Raymarine Hurricane Refit Program

<b>Who Is Eligible:</b>	Those individuals or marine businesses whose vessel(s) were damaged or a total loss due to a Hurricane that can validate the damage through insurance requirements.
<b>Qualifying Products:</b>	All new Raymarine products and accessories are eligible for this special promotion, with the exception of Thermal Night Vision products. <i>Installation charges, labor costs, shop supplies, haulout, travel, taxes, and other non-Raymarine hardware expenses are specifically excluded.</i>
<b>Instant Rebate:</b>	Eligible customers are entitled to a 10% Instant Rebate, up to a maximum of \$1,000, at the time of purchase.

### To file a claim:

1. Complete the Raymarine Hurricane Refit Program Qualification Form.
2. Submit a legible copy of the invoice or purchase receipt clearly showing the Raymarine products purchased.
3. In addition to the completed form and invoice, you must submit the following documentation to be paid on the claim:
  - a. A copy of your insurance card for proof of vessel ownership.
  - b. Insurance claim number and insurance adjusted damage appraisal form, including location, date, and cause of damage/loss.
